100 radio-telemetry tags for tracking European ground squirrels

1) Description of radio tags:

- a) tags should have collars,
- b) tags should have internal antennas,
- c) maximum weight 6 g,
- d) minimum impulse length 20 ms,
- e) minimum impulse rate 45 per second,
- f) battery ensuring continuous operation for a minimum of 4 months,
- g) frequency range 148 152 MHz,
- h) capability to distinguish at least 50 simultaneously operating tags,
- i) resistance of tags and collars to water and rodent teeth,
- 2) Place of tags delivery: seat of the ordering party.

Tender offers and any attachments should be written in the Polish or English language and signed by persons authorised to represent the tenderer according to the provisions of the registration certificate. Text that is crossed out or any changes to the text should also be confirmed with a signature.

- name and address of the tenderer;

Tender offers must be submitted to the office of the ordering party by 14.00 hrs on May 30, 2012 (post or courier delivery is accepted);

Tender offers will be opened in the office of the contracting party, at 15.00 hrs on May 30, 2012;

Tender offers should include gross price in PLN or another EU currency, or in USD. For the purpose of offer comparison the price will be converted into PLN using the average exchange rate of a given currency in the Polish National Bank (NBP) on the day of tender offers opening.

The tender price should include all costs associated with service delivery.

If the contractor's tender offer would result in a tax being imposed on the ordering party, in order to evaluate this offer the contracting party will add the tax or customs duty to be paid, in accordance with legal regulations that are in force.
